Residents Concerns:

Steve Foreman was invited to report on issues he had noted and complained to Thames water about after works completed by them. These consisted of badly repaired areas of the road. He was told that the works were guaranteed for a period of two years. His concerns were noted and documented, so that any subsequent problems can be passed back to Thames Water. He also reported on the leaking sewage pipe (since repaired) in Keysers road (Gravel lane) It was also noted that the works around Emerald were causing a lot of

disruption and that the site foreman was contacted about this. Steve was thanked for his

part in removing the overhanging trees adjacent to the access to the river.

Update on previous minutes:

AGM: A successful AGM was had on 15th September 2017 and minutes put on website for

Narrowboat issues:

A couple of residents had voiced concerns via email of noise, overstaying, foul water discharge, barking dogs and seemingly loutish behaviour by some of the occupants of the narrowboats moored on the river. Phil designed an electronic survey form to gauge opinion and see if other residents perceived a nuisance from these river users, with the idea that maybe the Riverside Avenue Residents Association should get involved if enough residents wanted us to. It was decided to publish the form on the website and put instructions on how

to take part in the survey in the next newsletter and gauge the response.

Road repairs:

The committee discussed at length the timing of repairs and access to the road whilst these were undertaken. It was felt that the gravel lane may have to be opened to keep access, but that the recently erected fences would cause problems. It was decided to contact the two

properties adjacent to the panels and warn them that it may become necessary to remove

them to enable temporary access.

Peter had already got quotes for a temporary road surface and bearing in mind access would

only be for a few days, damage would be minor and easily repaired. Bearing in mind the difficulty in contacting the residents concerned, it was decided that a letter should be

drafted and sent warning those affected of our intentions.

Peter offered to contact the contractors (Nicholls and sons) to find out about curing times of

the new surface and any suggestions regarding maintaining access. It was agreed that there would inevitably be some disruption, but as long as it was planned carefully and enough

notice given, it should not present a massive problem.
